## FINANCIAL STRENGTH AND PERFORMANCE POWER OUR MISSION

Acts continues to demonstrate strong financial health and operational performance, with total assets of \$2.9 billion. This solid foundation supports long-term stability and positions the organization for continued growth. A key indicator of this strength is occupancy, which stood at an impressive 97.7% of residences occupied or reserved as of December 31, 2025. Coupled with a steadily growing priority list, this demand reinforces our confidence in maintaining high occupancy levels.

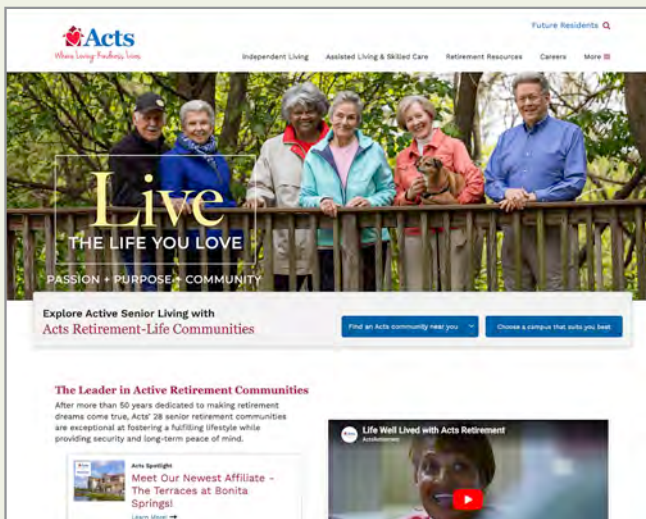


In 2025, 686 Acts team members were recognized for milestone anniversaries ranging from five to more than 40 years of service, underscoring a strong sense of purpose and connection within the organization.

## TRANSFORMING LIVES THROUGH GIVING

The **Acts Legacy Foundation** continues to transform lives through dynamic fundraising efforts that support vital community projects and establish purpose-driven funds aligned with Acts' mission. In 2025, more than **3,700 donors** contributed over **\$5.7 million** with the Foundation releasing approximately **\$5.8 million** of previously donated funds. Specifically, the Foundation funded approximately \$2.2 million for resident benevolence, \$1.9 million for campus enhancements and wellness programs, and over \$1.3 million to spiritual life, resident activities, and other restrictive purposes. Furthermore, the Foundation allocated more than \$440,000 to team member assistance programs, including scholarships and emergency support, demonstrating our steadfast commitment to holistic community enrichment.

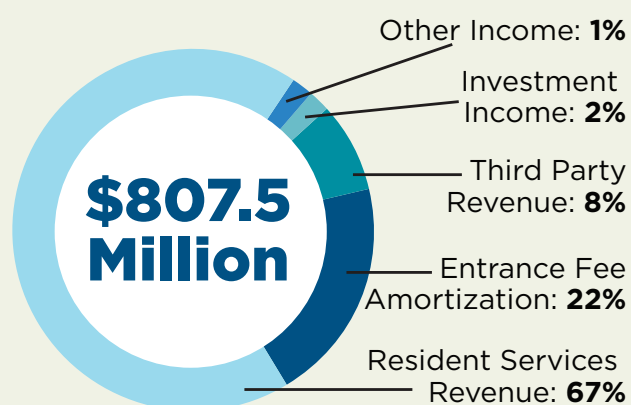

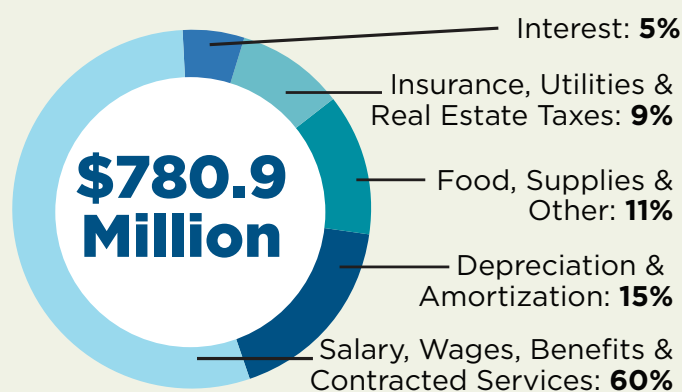
