
MS. SUSAN GRIFFIN & MS. MARTHA FRANKLIN St. Andrews Estates . Boca Raton, FL


Robert H. Sammis Brittany Pointe Estates . Lansdale, PA


MR. & MRS. F. BRUCE & NANCY ROBERTS Park Pointe Village, Rock Hill, SC
